4 **SEC. 1001. COMMODITY PROGRAMS.**

5 (a) REAUTHORIZATION OF COMMODITY PRO-
6 GRAMS.—

7 (1) REAUTHORIZATION.—Except as provided in
8 paragraph (2), title I of the Farm Security and
9 Rural Investment Act of 2002 (7 U.S.C. 7910 et
10 seq.) is amended by striking “2007” each place it
11 appears and inserting “2012”.

12 (2) EXCEPTIONS.—Paragraph (1) does not
13 apply with respect to the following:

14 (A) Section 1103(d)(2) of the Farm Secu-
15 rity and Rural Investment Act of 2002 (7
16 U.S.C. 7913(d)(2)).

17 (B) Section 1104(f) of the Farm Security
18 and Rural Investment Act of 2002 (7 U.S.C.
19 7914(f)).

1 (C) Section 1307(a)(6) of the Farm Secu-
2 rity and Rural Investment Act of 2002 (7
3 U.S.C. 7957(a)(6)).

7 (b) SPECIAL RULES.—

1 **SEC. 1102. FLEXIBLE MARKETING ALLOTMENTS FOR**
2 **SUGAR.**

5 matter preceding subparagraph (A) by striking “2007”
6 and inserting “2012”.

8 **SEC. 1201. DAIRY EXPORT INCENTIVE AND DAIRY INDEM-**
9 **NITY PROGRAMS.**

10 (a) **DAIRY EXPORT INCENTIVE PROGRAM.**—Section
11 153(a) of the Food Security Act of 1985 (15 U.S.C. 713a–
12 14(a)) is amended by striking “2007” and inserting
13 “2012”.

14 (b) **DAIRY INDEMNITY PROGRAM.**—Section 3 of Pub-
15 lic Law 90–484 (7 U.S.C. 450*l*) is amended by striking
16 “2007” and inserting “2012”.

17 **SEC. 1202. FUNDING OF DAIRY PROMOTION AND RESEARCH**
18 **PROGRAM.**

19 Section 113(e)(2) of the Dairy Production Stabiliza-
20 tion Act of 1983 (7 U.S.C. 4504(e)(2)) is amended by
21 striking “2007” and inserting “2012”.

22 **Subtitle D—Administration**

23 **SEC. 1301. ADJUSTED GROSS INCOME LIMITATION.**
