**AMENDMENT TO H.R. 1388, AS REPORTED  
OFFERED BY MR. PERRIELLO OF VIRGINIA**

In the table of contents in section 1(b) of the bill, strike the item relating to section 1804 and insert the following:

Sec. 1804. Innovative and Model Program Support and National Service Reserve Corps.

In section 193A(b)(20) of the National and Community Service Act of 1990 (as proposed to be inserted by section 1704 of the bill), strike “section 198F” and insert “section 198G”.

In the section heading of section 1804, insert “**AND NATIONAL SERVICE RESERVE CORPS**” after “**INNOVATIVE AND MODEL PROGRAM SUPPORT**”.

In the matter proposed to be inserted by section 1804 of the bill, amend the heading relating to part II of subtitle H of the National and Community Service Act of 1990 to read as follows:

1 **PART II—INNOVATIVE AND MODEL PROGRAM**  
2 **SUPPORT AND NATIONAL SERVICE RESERVE**  
3 **CORPS**

In section 1804 of the bill, strike the close quotation mark and following period after the matter proposed to be inserted by such section, and insert at the end of such section the following:

4 **“SEC. 198E. NATIONAL SERVICE RESERVE CORPS.**

5 “(a) DEFINITIONS.— In this section—

6 “(1) the term ‘term of national service’ means  
7 a term or period of service—

8 “(A) under subtitle C, E, or G or sections  
9 198B or 198F of this Act, or under part A of  
10 title I of the Domestic Volunteer Service Act of  
11 1973 (42 U.S.C. 4951 et seq.); or

12 “(B) under an annual service requirement,  
13 which may include an annual training session  
14 under subsection (b), as determined by the Cor-  
15 poration of not less than 10 hours.

16 “(2) the term ‘National Service Reserve Corps  
17 member’ means an individual who—

18 “(A) has completed a term of national  
19 service;

1           “(B) has successfully completed training  
2           described in subsection (b) within the previous  
3           2 years; and

4           “(C) has indicated interest to the Corpora-  
5           tion in responding to national disasters and  
6           other emergencies in a timely manner through  
7           the National Service Reserve Corps.

8           “(3) ESTABLISHMENT OF NATIONAL SERVICE  
9           RESERVE CORPS.—The Corporation shall establish a  
10          National Service Reserve Corps to prepare and de-  
11          ploy National Service Reserve Corps. In carrying out  
12          this section, the Corporation may work with organi-  
13          zations representing individuals who have completed  
14          a term of national service, as well as directly with  
15          such individuals.

16          “(b) ANNUAL TRAINING.—The Corporation shall, in  
17          consultation with the Administrator of the Federal Emer-  
18          gency Management Agency, conduct or coordinate annual  
19          training sessions for individuals who have completed a  
20          term of national service, and who wish to join the National  
21          Service Reserve Corps.

22          “(c) CERTIFICATION OF ORGANIZATIONS.—

23                 “(1) On a biannual basis, the Corporation shall  
24                 certify organizations with demonstrated experience  
25                 in responding to disasters, including through using

1 volunteers, for participation in the program under  
2 this section.

3 “(2) The Corporation shall ensure that every  
4 certified organization is—

5 “(A) prepared to respond to major disas-  
6 ters or emergencies;

7 “(B) prepared and able to utilize National  
8 Service Reserve Members in responding; and

9 “(C) willing to respond in a timely manner  
10 when notified by the Corporation of a disaster  
11 or emergency.

12 “(d) DATABASES.—The Corporation shall develop or  
13 contract with an outside organization to develop—

14 “(1) a database of all National Service Reserve  
15 Corps members; and

16 “(2) a database of all nonprofit organizations  
17 that have been certified by the Corporation under  
18 subsection (c).

19 “(e) DEPLOYMENT OF NATIONAL SERVICE RESERVE  
20 CORPS.—

21 “(1) IN GENERAL.—If a major disaster or  
22 emergency designated by the President under the  
23 Robert T. Stafford Disaster Relief and Emergency  
24 Assistance Act (42 U.S.C. 5121 et seq.) occurs and  
25 the Corporation, in consultation with the Adminis-

1       trator of the Federal Emergency Management Agen-  
2       cy, determines is an incident for which National  
3       Service Reserve Corps members are prepared to as-  
4       sist, the Corporation shall—

5               “(A) deploy interested National Service  
6       Reserve Corps members on 30-day assignments  
7       to assist with local needs related to preparing  
8       or recovering from the incident in the affected  
9       area, through organizations certified under sub-  
10      section (c);

11              “(B) make travel arrangements for the de-  
12      ployed National Service Reserve Corps members  
13      to the site of the incident; and

14              “(C) provide funds to those organizations  
15      that are responding to the incident with de-  
16      ployed National Service Reserve Corps mem-  
17      bers, to enable the organizations to coordinate  
18      and provide housing, living stipends, and insur-  
19      ance for those deployed members.

20              “(2) ALLOWANCE.—Any amounts that are uti-  
21      lized by the Corporation from funds appropriated  
22      under section 501(a)(2)(F) to carry out paragraph  
23      (1) for a fiscal year shall be kept in a separate fund.  
24      Any amounts in such fund that are not used during  
25      a fiscal year shall remain available to use to help or-

1 organizations pay Reserve Corps Members an allow-  
2 ance, determined by the Corporation, for out-of-  
3 pocket expenses.

4 “(3) INFORMATION.—The Corporation, the  
5 State Commissions, and entities receiving financial  
6 assistance for programs under subtitle C, E, or G or  
7 section 198F of this Act, or under part A of title I  
8 of the Domestic Volunteer Service Act of 1973 (42  
9 U.S.C. 4951 et seq.), shall inform participants of  
10 those programs of the National Service Reserve  
11 Corps upon the participants’ completion of their  
12 term of national service.

13 “(4) COORDINATION.— In deploying National  
14 Service Reserve Corps members under this sub-  
15 section, the Corporation may consult and, as appro-  
16 priate, partner with Citizen Corps programs in the  
17 affected area.”.

In the matter proposed to be inserted by section 1805 of the bill, redesignate section 198E of the National and Community Service Act of 1990 as section 198F.

In the matter proposed to be inserted by section 1806 of the bill, redesignate section 198F of the National and Community Service Act of 1990 as section 198G.

In the table of contents of the National and Community Service Act of 1990 (as proposed to be amended by section 4104 of the bill), strike the item relating to part II of subtitle H and insert the following:

PART II—INNOVATIVE AND MODEL PROGRAM SUPPORT AND NATIONAL SERVICE RESERVE CORPS

In the table of contents of the National and Community Service Act of 1990 (as proposed to be amended by section 4101 of the bill), after the item relating to section 198D, insert the following:

Sec. 198E. National Service Reserve Corps.

In the table of contents of the National and Community Service Act of 1990 (as proposed to be amended by section 4101 of the bill), strike the item relating to section 198E and insert the following:

Sec. 198F. Social Innovation Fund.

In the table of contents of the National and Community Service Act of 1990 (as proposed to be amended by section 4101 of the bill), strike the item relating to section 198F and insert the following:

Sec. 198G. National Service Programs Clearinghouse.
