

**AMENDMENT TO THE RULES COMMITTEE PRINT
OF H.R. 4310
OFFERED BY MR. WELCH OF VERMONT**

At the end of subtitle I of title V, add the following
new section:

1 SEC. 596. INCREASED FUNDING FOR STATE-LED PROGRAMS
2 OF OUTREACH UNDER YELLOW RIBBON RE-
3 INTEGRATION PROGRAM.

4 (a) PROGRAMS OF OUTREACH.—Of the amounts au-
5 thorized to be appropriated by this Act or otherwise made
6 available for fiscal year 2013 for the Department of De-
7 fense, not less than \$50,000,000 may be used for State-
8 led programs of outreach carried out pursuant to sub-
9 section (j) of section 582 of the National Defense Author-
10 ization Act for Fiscal Year 2008 (10 U.S.C. 10101 note),
11 as added by section 590(c) of the National Defense Au-
12 thorization Act for Fiscal Year 2012 (Public Law 112–
13 81; 125 Stat. 1438).

14 (b) FUNDING.—

15 (1) INCREASE.—Notwithstanding the amounts
16 set forth in the funding tables in division D, the
17 amounts authorized to be appropriated in section
18 301 for operation and maintenance, as specified in

1 the corresponding funding tables in section 4301 for
2 OSD, Defense-wide, operation and maintenance, is
3 hereby increased by \$50,000,000, to be distributed
4 to the Office of Reserve Affairs for outreach pro-
5 grams of the Yellow Ribbon Reintegration Program.

6 (2) REDUCTIONS.—Notwithstanding the
7 amounts set forth in the funding tables in division
8 D, the following reductions are made:

9 (A) The amount authorized to be appro-
10 priated in section 4101 for Missile Procure-
11 ment, Army, as specified in the funding table in
12 division D, is hereby reduced by \$10,000,000,
13 with the amount of the reduction to be derived
14 from line 004, Hellfire missiles.

15 (B) The amount authorized to be appro-
16 priated in section 4101 for Weapons Procure-
17 ment, Navy, as specified in the funding table in
18 division D, is hereby reduced by \$7,300,000,
19 with the amount of the reduction to be derived
20 from line 004, Advanced Medium Range Air-to-
21 Air Missiles.

22 (C) The amount authorized to be appro-
23 priated in section 4101 for Weapons Procure-
24 ment, Navy, as specified in the funding table in
25 division D, is hereby reduced by \$5,500,000,

1 with the amount of the reduction to be derived
2 from line 006, Joint Standoff Weapon missiles.

3 (D) The amount authorized to be appro-
4 priated in section 4101 for Weapons Procure-
5 ment, Navy, as specified in the funding table in
6 division D, is hereby reduced by \$12,800,000,
7 with the amount of the reduction to be derived
8 from line 009, Hellfire missiles.

9 (E) The amount authorized to be appro-
10 priated in section 4101 for Missile Procure-
11 ment, Air Force, as specified in the funding
12 table in division D, is hereby reduced by
13 \$15,000,000, with the amount of the reduction
14 to be derived from line 004, Advanced Medium
15 Range Air-to-Air Missiles.
